“Black Embodiment and the Violence of Whiteness”

Abstract: In this talk, I will discuss both spectacular and mundane ways in which whiteness “touches” the Black body. Implicit within this distinction involves an interrogation of the “innocence” of whiteness and how the unveiling of whiteness demonstrates its haptic (or as always already touching) nature. Given this, how do we make sense of the distinction between “good” whites and “bad” whites? Is the distinction still sustainable, and in what form? I gesture toward what I see as the necessary “insurrection at the level of ontology” (Judith Butler’s language) of whiteness itself. Here, I will argue that whiteness must be in crisis, disoriented, and un-sutured.
